

JOHNSTOWN BMX FUNDRAISING POLICY 2011

*****ALL FUNDRAISERS ARE OPTIONAL*****

Welcome to the 2011 Race Season, we are once again preparing for a busy season filled with races and activities. In order to keep the track functioning we are asking each rider to participate in the following fundraising. Please help us make this a successful year.

Requirements:

To begin your fundraising account you must provide the following items

- **\$60 PER RIDER.** This money can be earned by participating in one of the many **RIDER FUNDRAISERS** or "buyout"
- Volunteer at the Track at least Five Times (This must be notified to an officer) "NO buyout"
- Signed Fundraising Policy Form
- Participate in one **TRACK FUNDRAISER – Profits go directly to track only** "buyout - \$30"
(**ONLY** 2 - Horse Race tickets or 6 - Calendar lottery ticket)

Opportunities once completed:

- Rider will attend end of year banquet for **FREE** on **DATE: TBA at DELGROSSO'S AMUSEMENT PARK (ride, water park pass, giveaway and meal)**
- Receive Trophy (at banquet)
- Will receive any additional Awards, prizes or gifts given

Any additional profit you earn you can use towards BMX related items. We will keep track of your profits in an individual account. You can receive reimbursement from the account for BMX related items, under the following terms:

1. Must present receipts to Jodi with the BMX item listed
2. Reimbursement will only be done once a month. Refer to the race schedule for this date.
3. Once a check has been written for your reimbursement it will be your responsibility and Johnstown BMX will NOT be able to reissue a new one due to the cost of stop payments. (unless you are willing to cover that cost)

These items include:

NBL fees, racing equipment, bikes, bike parts, helmets, BMX clothing. If there would be a question of whether or not an item would be: "BMX related" please see a Johnstown BMX officer.

If for any reason, you decide to leave our organization the monies will be forfeited to JOHNSTOWN BMX!!! You must have a current NBL license and be actively racing at JOHNSTOWN BMX. We reserve the right to make changes to this policy if needed!!!

You may also earn credit to your account with the sponsorship pack, which is a huge boost for our track. For any sponsorship, other than rider sponsorship, your rider will receive 10% towards their fundraising. For instance, if your rider sells a fence sign sponsor for \$150, he will receive \$15 in his account.

Payments for Fundraisers: NO EXCEPTIONS TO THESE

- Payment in full on due date (prior to receiving your merchandise)
- Cash or one check (written to Johnstown BMX) written from the BMX rider's parents or guardian. NO outside checks will be accepted.

You may start your accounts on January 1, 2011 and end on December 31, 2011. Any monies remaining in the account after December 31, 2011 will become the property of Johnstown BMX. Contribution amount may change from year to year depending on the track needs.
